The Minister of Trade, Industry and Competition invites nominations from the public for candidates to serve as Deputy Chief Commissioner of the International Trade Administration Commission of South Africa (ITAC).

The successful candidate will be part of the Senior Management of an important public institution with a mandate to promote employment and investment, and raise incomes in South Africa and within the SACU through administration of International trade. The role of ITAC is set out in the International Trade Administration Act, 2002.

**Qualification of Nominees:** To be eligible for appointment and to continue to hold office as a member of the Commission, a person must be ordinarily resident in the Republic; and have suitable qualifications and experience in economics, accounting, law, commerce, agriculture, industry or public affairs.

A person may not be a member of the Commission if that person is an office-bearer of any party, movement, organisation or body of a partisan political nature; is an un-rehabilitated insolvent; has been found mentally unfit by an order of a competent court; or has been convicted of an offence committed after the Constitution of the Republic of South Africa, 1993 took effect, and sentenced to imprisonment without the option of a fine.

**Nomination procedure:** Nominations must be submitted in writing and must include the following:

- A detailed Curriculum Vitae
- Certified copy of the identity document; and
- Certified copies of qualifications obtained. It is the nominee's responsibility to have foreign qualifications verified by the South African Qualifications Authority (SAQA).

**Term of Office of the Deputy Chief Commissioner:** The Deputy Chief Commissioner will be appointed for a period of 5 years.

**Note:** Background verification, including criminal record, social media and citizenship checks, will form part of the selection process • Preference will be given to candidates whose appointment will enhance representivity.
