I, Enoch Godongwana, Minister of Finance, in my capacity as the Minister of Finance, hereby publish, in accordance with sections 20 and 25 of the Division of Revenue Act, 2022 (Act No. 5 of 2022), the attached Explanatory Memorandum and Schedules:

- (a) The disaster allocations and the conversion of conditional grants to municipalities in terms of sections 20 and 25 of the Division of Revenue Act, 2022 (Act No. 5 of 2022); and
- (b) The additional allocations on the converted allocation to Provincial Emergency Housing Grant, Provincial Disaster Recovery Grant, and Neighbourhood Development Partnership Grant.

For ease of reference only and where applicable, the attached Schedules reflect the main allocations, first and second adjustments, and total adjusted allocations.

Explanatory Memorandum to the Allocations set out in the attached Schedule

This Gazette is published in terms of the Division of Revenue Act, 2022, (Act No. 5 of 2022) (DoRA), and provides information regarding the disaster allocations and the conversion of conditional grants to municipalities in the 2022/23 financial year.

The disaster allocations and the conversion of conditional grants is done in terms of sections 20 and 25 of DoRA.

CONVERSION OF FUNDS:

The approval has been granted by National Treasury to convert a portion of the Neighbourhood Development Partnership Grant (NDPG) direct allocation to the indirect NDPG. The reason for conversion is because the affected municipalities are experiencing various challenges that impact the implementation of the direct NDPG and rolling out of infrastructure in underserved communities. The municipalities that are affected by the conversion are from Gauteng and KwaZulu-Natal (KZN) provinces, namely Emfuleni Local Municipalities, Mogale City Local Municipality and KwaDukuza Local Municipality, respectively.

National Treasury also approved the conversion of the Municipal Emergency Housing Grant in order to necessitate the shortfall of the Provincial Emergency Housing Grant. An amount of R120 million is converted to PEHG in order to respond to the flood disasters that occurred in KZN.

Furthermore, National Treasury approved the request to convert the Municipal Disaster Recovery Grant (MDRG) to Provincial Disaster Recovery Grant (PDRG) because of the shortfall within the MDRG allocation. An amount of R140 million has been converted to PDRG in order to respond to the disasters that occurred in KZN and the Eastern Cape provinces.

The approval for these conversions are done through the issue of the gazette in terms of sections 20 and 25 DoRA.

UNALLOCATED PROVISIONS FOR DISASTER RESPONSE:

The Department of Cooperative Governance (DCoG) through National Disaster Management Centre (NDMC) published a National Disaster Declaration dated 18 April 2022 (gazette No 46247). The declaration was issued following the severe weather events affecting municipalities in KwaZulu-Natal and Eastern Cape provinces. The gazette was done in terms of section 3 of the Disaster Management Act, 2002 (Act No.57 of 2002).

National Treasury approved the request from DCOG through the NDMC to allocate funds to municipalities in the following provinces the KwaZulu-Natal and the Eastern Cape against the 2022/23 Municipal Disaster Response Grant (MDRG) in response to the flood disasters.

National Treasury in consultation with the Department of Human Settlements (DHS) approved the allocation of funds to the municipality in Eastern Cape against the Municipal Human Settlements Grant (MEHG), in order to provide a relief after the occurrence of the disasters.
