**LABOUR RELATIONS ACT, 1995****NOTICE OF INTENTION TO CANCEL THE REGISTRATION OF A TRADE UNION**

I, Lehlohonolo Molefe, Registrar of Labour Relations, hereby, in terms of section 106(2B) of the Labour Relations Act (LRA) give notice of my intention to cancel the registration of **University and allied Workers Union (UAWU) (LR2/6/2/2529)** for the following reasons:

- The organisation failed to comply with the provisions of section 98, 99 and 100 of the Act, and
- The organisation ceased to function in terms of its constitution

The organisation and all interested parties are hereby invited to make written representations as to why the registration should not be cancelled. **Only representations pertaining to this Notice will be considered. All correspondence should refer to case number: 2022/276.**
