NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008 (ACT NO. 59 OF 2008)**NOTICE OF DECISIONS ON APPLICATIONS RECEIVED IN TERMS OF REGULATION 6(4) OF THE WASTE EXCLUSION REGULATIONS, 2018, FOR THE EXCLUSION OF A WASTE STREAM OR A PORTION OF A WASTE STREAM FROM THE DEFINITION OF WASTE FOR BENEFICIAL USE**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, hereby under regulation 6(4) of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, published under Government Notice R.715 of Government *Gazette* 41777 of 18 July 2018, publish the decisions on applications for the exclusion of certain waste streams or a portion of such waste streams, from the definition of waste, for the purposes of certain beneficial uses, as indicated in the Schedule hereto.

In consideration of the applications, the criteria contemplated in regulation 7 and the risk assessment contemplated in regulation 8 of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, were taken into account. The waste streams or portion of such waste streams excluded from the definition of waste, must comply with the risk management plans based on the risk assessments. Annual reports in terms of regulation 10 of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, must be submitted to the Department.
