### NOMINATION OF CANDIDATES FOR APPOINTMENT TO THE AGRICULTURAL RESEARCH COUNCIL: AGRICULTURAL RESEARCH ACT, 1990 (ACT No. 86 OF 1990)

The term of office of members of the council of the Agricultural Research Council is to expire at the end of June 2023.

The Minister of Agriculture, Land Reform and Rural Development, hereby invites persons, stakeholders, the Premier of each Province as well as the Portfolio and Select Committees responsible for Agriculture, Land Reform and Rural Development in Parliament to provide her with the names of persons to be considered for appointment as members of the council of the Agricultural Research Council.

In terms of the provisions of the Act, the nominees shall be considered for appointment by virtue of their knowledge and experience of agriculture, marketing, the training of agriculturalists and veterinarians, business and financial management, the law, the environment, rural development, or research, development or technology transfer in the field of agriculture.

No person falling within the categories described in section 9(5) of the Act shall qualify for nomination or appointment to the Council. Suitable candidates would be subjected to a personnel suitability check (criminal record, citizen, qualifications/study verification as well as previous employment verification and financial asset/record check).

The following documents must accompany each nomination:

1. A detailed curriculum vitae;
2. Written acceptance of the nomination by the nominee;
3. ID copy; and
4. Documentary proof of all qualifications.

Nominations should reach the under-mentioned address no later than 19 May 2023: Chief Director: Executive Support Services, Department of Agriculture, Land Reform and Rural Development, Private Bag X250, Pretoria, 0001.
