AND PUBLICATION OF EXPLANATORY SUMMARY OF BILL**

In terms of rule 276(1)(b) and (c) of the Rules of the National Assembly—

- (a) prior notice is hereby given of the introduction by the Minister of Finance of the Public Procurement Bill (“the Bill”) in the National Assembly in the second quarter of 2023; and
- (b) the following explanatory summary of the Bill is hereby published:

The Bill provides for a single regulatory framework for public procurement and provide, among others, for—

- the establishment of a Public Procurement Office within the National Treasury and its functions;
- the functions of provincial treasuries;
- the functions of procuring institutions;
- measures to enhance the integrity of the procurement process through access to procurement information and other transparency measures;
- a preferential procurement framework;
- general procurement requirements;
- regulations on a procurement system and methods of procurement;
- different regulations for different types of procurement and categories of procuring institutions;
- the use of information and communications technology in procurement;
- dispute resolution mechanisms; and
- the repeal and amendment of certain laws.

Die Wetsontwerp maak voorsiening te maak vir ’n enkele reguleringsraamwerk vir openbare verkryging en maak, onder meer, voorsiening vir—

- die daarstelling van ’n Openbare Verkrygingskantoor in die Nasionale Tesourie and sy funksies;
- die funksies van provinsiale tesourieë;
- die funksies van verkrygingsinstellings;
- maatreëls om die integriteit van die verkrygingsproses deur toegang tot verkrygingsinligting en ander deursigtigheidsmaatreëls;
- ’n voorkeur-verkrygingsraamwerk;
- algemene verkrygingsvereistes;
- regulasies oor ’n verkrygingstelsel en metodes van verkryging;
- verskillende regulasies vir verskillende soorte van verkryging en kategorieë van verkrygingsinstellings;
- die gebruik van inligting- en kommunikasietegnologie in verkryging;
- meganismes vir dispuutresolusie; en
- die herroeping en wysiging van sekere wetgewing.
