PROPOSAL FOR THE ESTABLISHMENT OF LOWER MFOLOZI WATER USER ASSOCIATION, KWAZULU NATAL PROVINCE

I, Senzo Mchunu, the Minister of Water and Sanitation, hereby declare in terms of section 92(3) of the National Water Act, 1998 (Act No. 36 of 1998) that –

- (a) the proposed name is the Lower Mfolozi Water User Association (WUA).
- (b) the proposed area of operation aligns to the boundaries of the W21L, W22L W23 A, B, C, and D. The said area of operation of the WUA will encompass area from just above the confluence of the White and Black Mfolozi Rivers near the southern boundaries of the Hluhluwe Mfolozi Game Reserve up to the Mfolozi River Mouth at St Lucia.
- (c) the area lies within the Pongola Mtamvuna Water Management Area, which falls within the province of KwaZulu-Natal. The area of operation falls within the jurisdiction of King Cetshwayo, uMkhanyakude District Municipalities, Mbonambi and Mtubatuba Local Municipalities.
