NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008 (ACT NO. 59 OF 2008)**NOTICE OF INTENTION TO TAKE A DECISION ON APPLICATIONS FOR THE EXCLUSION OF A WASTE STREAM OR A PORTION OF SUCH A WASTE STREAM FOR BENEFICIAL USE, FROM THE DEFINITION OF WASTE**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment hereby in terms regulation 6(3) of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, published under Government Notice R.715 of *Government Gazette* 41777 on 18 July 2018, read with sections 72 and 73 of the National Environmental Management: Waste Act, 2008 (Act No.59 of 2008), give notice of my intention to take decisions on applications received for the exclusion of a waste stream or a portion of a waste stream from the definition of waste for a certain beneficial use, as indicated in the Schedule hereto.

The Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, prescribe the manner in which a person or a category of persons may apply to the Minister for the exclusion of a waste stream or a portion of a waste stream from the definition of waste. The Regulations sets out the process and procedure to be followed before the Minister takes a decision on the applications.

In consideration of the applications, the criteria contemplated in regulation 7 and the risk assessment contemplated in regulation 8 of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, must be taken into account. Once a waste stream has been excluded from the definition of waste, a risk management plan, which is based on the risk assessment, must be complied with. Annual reports in terms of regulation 10 of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, must be sent to the Department.
