CANDIDATE TO SERVE AS MEMBER OF THE  
SOUTH AFRICAN PHARMACY COUNCIL**

The South African Pharmacy Council (SAPC) is a statutory body established in terms of the Pharmacy Act, 53 of 1974, ("the Act") to promote the health of the population of the Republic and advise the Minister or any other person on any matter relating to pharmacy and promote the provision of pharmaceutical care.

The Honourable Minister of Health, Dr M.J. Phaahla, hereby invites the nomination of four suitable candidates, who are South African citizens, to be appointed by the Minister in terms of Section 5(1)(e) of the Act for a period of five (5) years with effect 01 January 2024 as follows:

- one of whom shall be a person appointed on account of his or her legal knowledge.

In respect of the remaining three candidates, preference may be given to:

- one of the three remaining nominees would preferably be a person well-versed in consumer/patient rights, who may have previously served in a council/organisation of a similar nature.
- two other persons, who may have previously served in a council/organisation of a similar nature and/or pharmacy owners who have a footprint in the previously disadvantaged communities and have a proven track record of championing their course.
