

EQUIPMENT AUTHORISATION CERTIFICATION PROCESS**

1. The Independent Communications Authority of South Africa ("**the Authority**") hereby gives notice inviting all stakeholders to a workshop in relation to the ICASA Designated Certification Bodies Programme ("ICASA DCB Programme"). The workshop will be held at the Authority's Head Office, 350 Witch-Hazel Avenue, Eco Point Office Park, Eco Park, Centurion, on 26 September 2023 from 10:00 to 14:00.
2. The ICASA DCB Programme outlines the requirements needed for a certification body to become a designated certification body in accordance with the Equipment Authorisation Regulations, 2022 ("the Regulations"), published in Government Gazette No. 46146 (Notice No. 1949) of 31 March 2022.
3. The Authority developed the Regulations published in Government Gazette No. 46146 to implement the Conformity Assessment Framework for Equipment Authorisation ("CAFEA") published in Government Gazette No. 43047 (Notice No. 200 of 2020) of 25 February 2020.
4. A designated certification body will assist the Authority with the certification application process as provided for in regulation 8 of the Regulations.
