REGULATIONS ON THE FORMAT OF THE APPLICATION FOR A RADIOACTIVE WASTE DISPOSAL CERTIFICATE

I, Mr. Samson Gwede Mantashe, Minister of Mineral Resources and Energy, in terms of section 23(1) read with section 29(1)(a) of the National Radioactive Waste Disposal Institute Act, 2008 (Act No. 53 of 2008), hereby publish for public comment, the draft Regulations on the Format of the Application for a Radioactive Waste Disposal Certificate, as set out in the Schedule.

Definitions

In these Regulations a word or expression to which a meaning has been assigned in the Act has that meaning and, unless the context indicates otherwise—
 "Act" means the National Radioactive Waste Disposal Institute Act, 2008 (Act No. 53 of 2008);

"Applicant" means a person who has submitted an application for a radioactive waste disposal certificate in terms of section 23 of the Act;

"certificate holder" means the holder of a radioactive waste disposal certificate granted by the Institute in terms of section 23(2)(b) of the Act;

"Chief Executive Officer" means the person appointed or alternatively designated as such in terms of section 16(1) or 16(5)(a) of the Act;

"disposal" means the emplacement of waste in an authorised waste disposal facility;

"generator of radioactive waste" means any person authorised by a South Africa

Regulator in terms of relevant legislation and whose operations generate radioactive waste;

"radioactive waste acceptance and disposal criteria" means site-specific document developed by the Institute in terms of section 5(c) of the Act; and

"waste package" means the product of conditioning that includes the waste form and any container(s) and internal barriers (e.g. absorbing materials and liner), as prepared in accordance with requirements for handling, transportation, storage and/or disposal.

Purpose and Application of Regulations

- 2. (1) The purpose of these Regulations is to establish the prescribed format of the application for a radioactive waste disposal certificate for the disposal of radioactive waste at an authorised waste disposal facility.
- (2) These Regulations apply to a generator of radioactive waste in the Republic who must dispose of radioactive waste in an authorised waste disposal facility and govern the application process thereof.

Lodging of application for a radioactive waste disposal certificate

- 3. (1) A generator of radioactive waste wishing to dispose of radioactive waste in an authorised waste disposal facility must make an application for a radioactive waste disposal certificate to the Chief Executive Officer, in terms of section 23(1) of the Act.
- (2) An applicant shall lodge in writing a completed application on FORM A illustrated in Annexure A of the Regulations.
 - (3) The application must be accompanied by the following documents—
- (a) certified copies of the applicant's company registration documents. Where an
 applicant is a creature of statute, reference to the founding legislation must be
 made in the application form;
- (b) board or shareholder resolution authorising the application and designated official to make the application; and

- (c) copy of a municipal account as proof of address.
- (4) An applicant must submit two (2) hardcopies (including an original) of the applications as well as an electronic copy of the application via email to info@nrwdi.org.za.
- (5) The Chief Executive Officer shall assess the application and ensure the information is in compliance with the waste acceptance and disposal criteria as contemplated in section 5(c) of the Act.
 - (6) No radioactive waste disposal certificate shall be issued—
- (a) if the application is not accompanied by any of the information listed in subregulation (3) above, the application will be considered incomplete and will not be processed by the Institute; and
- (b) if the Institute has not assessed and inspected the radioactive waste for disposal in terms of the compliance with the waste acceptance and the disposal criteria as developed by the Institute in accordance with section 5(c) of the Act.
- (7) The Institute must inform the applicant of the outcome of its application in terms of section 23(2) of the Act in writing within ninety (90) days of the Institute receiving a complete application for a radioactive waste disposal certificate.

Short title and commencement

4. These Regulations are called the "Regulations on the Format of the Application for a Radioactive Waste Disposal Certificate" and will come into operation on the date of promulgation in the *Gazette*.
