Purchase of Designated Commodities During the 2015 Crop Marketing Season

Food Reserve Agency

PURSUANT to section 7 (2) (3) of the Food Reserve Act Cap. 225 of the Laws of Zambia, the Food Reserve Agency hereby announces its plan for purchases of designated agricultural commodities during the 2015 Marketing season. This year's crop marketing program will commence on the 1st of June, 2015 and will close on 31st of October, 2015 subject to market dynamics.

Commodities to be purchased:

Maize and Paddy rice

Quantities to be purchased:

Maize — Minimum of 500,000 metric tons

Paddy rice — Minimum of 2,100 metric tons

Purchase locations:

A total of 1,200 satellite depots shall be opened in 75 Districts.

Farmers shall deliver their crops to designated satellite depots which will be operated by FRA representatives as buying agents;

- Crop deliveries shall be confirmed by FRA representatives at main holding depots who shall then process farmers' payments.
