Introduction

The Government of the Republic of Zambia issued Statutory Instrument 79 of 2013, called the electricity Grid Code whose objective is to regulate participants in the generation, transmission, bulk supply and operation and maintenance of Interconnected Power System through the Energy Regulation Board. ZESCO Limited is among these participants to be regulated and is therefore obligated to adhere to the provisions of the Statutory Instrument. *Scope* 

ZESCO wishes to engage a qualified Consultant to provide services in testing models for three generators and at the same time build capacity amongst power station and system operationss engineers to carry out this work for the rest of the units. The full scope of work entails provision of the following services:

Measuring and testing of three hydro generating units i.e. one at Kafue Gorge Power Station and two at Kariba North Bank Power Station for Zambian Grid Code compliance;

Using the developed models and the Southern African Power Pool Network Models, determine suitable Power System Stabiliser setting for the hydro generating units at Kafue Gorge Power Station and Kariba North Bank Station and implement the setting to ensure adquate damping of low frequency power oscillations as well as correct operation during transient response of the excitation system and governors. The Consultant shall also be expected to develop criteria for PSS monitoring and review;

off site and onside training of four engineers in grid code compliance testing, system dynamic modeling and validation; as well as power system stabiliser tuning; and

Supply of all the relevant test equipment to be used on this project.

Expected Benefits of Modling and Testing of Generating Units for Grid Code Compliance

The following benefits are expected from the implementation of this project:

- (a) Compliance to Zambian Gride Code;
- (b) Development of the governor and excitation system models for use in dynamic (Steady state and transient) system studies;
- (c) Determination of suitable PSS setting for the hydro generating units at Kafue Gorge Power Station and Kariba North Bank Power Station and subsequent implementation to ensure adquate damping of low freqquency power oscillations as well as correct operation during transient response of the excitataion system and governors;
- (d) Development of in-house capacity to conduct Grid Code compliance tests and PSS tunining of Units; and
- (e) Acqistion of all the relevant test equiment and software to be used for conducting Grid Code compliance test and PSS tuning.

Terms of Reference for the Assignment

In delivering the assignemnt, Consultant shall as a minimum be required to:

 (a) Perform a site visit for technical data collection and verification as well as to set in place arrangement for measurement and testing;

- (b) Prepare and submit for approval a detailed measurement and testing plan for this project. Note that unit outages will need to be kept to a minimal and therefore, the Consutant is requested to ensure that work cluster are created wherever possible to miximize any given unit outage. No site measurement and tests shall be carried out without an approved specific site test plan;
- (c) Provide a miimum of two weeks off-site training for five engineers in grid code compliance test, system dynamic modeling and validation as well as PSS training and in two weeks onsite training for up to a mnimum of ten engineers. The training shall be done prior to the commencement of the site measurement and testing as wellas model development. - (e) Derive the governor and excitation system models;

- (g) Conduct simulation test to validate the models. The Consultant shall be required to provide the list of tests to be performed for validation of the models for approval by ZESCO prior to commencement or works;
