# Establishment of New Constituencies

IN EXERCISE of the powers contained in Article 58 of the Constitution of Zambia (Amendment) Act No. 2 of 2016, the following Gazette Notice is hereby made:

NOTICE IS HEREBY GIVEN to the general public that pursuant to the increase in the number of constituencies in the Constitution of Zambia(Amendment) Act No. 2 of 2016 from 150 to 156, the Electoral Commission of Zambia conducted delimitation and created six new constituencies indicated in Schedule 1 hereto.

NOTICE IS FURTHER GIVEN to the general public that during the 2016 Delimitation, the Electoral Commission of Zambia renamed the constituencies indicated in Schedule 2 and renumbered the constituencies specified in Schedule 4.

The narrative descriptions of the constituencies referred to in Schedule 1 are outlined in Schedule 3.

The new, renamed and renumbered constituencies shall only take effect after the next dissolution of Parliament.

The copies of the maps of the new constituencies are available for inspection by members of the public at the Electoral Commission of Zambia Head Office situated at Elections House, Haile Selassie Avenue, Longacres, Lusaka and at the respective District Councils.
