#### Securities and Exchange Commission

#### Directives on Prohibited Product Activities by Capital Markets Operations, 2018

#### 1.1 DIRECTIVES TO CAPITAL MARKETS OPERATORS

Pursuant to the provisions of sections 11 and 212 of the Securities Act, No. 41 of 2016 (the "Securities Act") and in a bid to ensure investor protection in accordance with its mandate under section 9 (2) of the Securities Act, the Securities and Exchange Commission (the "Commission") hereby directs all capital markets operators to ensure that products provided or offered to the investing public or clients by such operators and which are held out to, or understood by, the investing public or clients to be within the scope of the operator's licence issued by the Commission, are authorised by, or registered with, the Commission.

#### 1.2 Background

- 1.2.1 The Commission has noted that some capital markets operators are offering products, which are not permitted under their licences, and are receiving funds under the auspices of fund management or wealth or portfolio management services and are for example, designing the same as commercial paper. The capital markets operators concerned, are receiving money from the investing public or clients as a wealth management or similar service and are promising to return the funds after a specified tenure or period of time. The Commission understands that clients are being promised a return in the form of interest, profit or other form of return at the expiry of such tenure or period of time.
- 1.2.2 The Commission has further noted that the capital markets operators concerned may have held out to, or caused, the investing public or clients to be of the understanding that such products are permitted under the licence issued by the Commission to the operator.
- 1.2.3 In addition, the Commission has observed that there are instances where securities acquired on behalf of a client, after receipt of funds, were not registered in the client's name with the appropriate central securities depository.

#### 1.3 PROHIBITED PRODUCT ACTIVITY

- 1.3.1 Licensing and regulation of capital markets operators is provided for under Part V of the Act. In particular, dealers are licensed under section 32 of the Act while investment advisers are licensed under section 33 of the Act.
- 1.3.2 The licences referred to in paragraphs 1.2.2 and 1.3.1 of these Directives do not authorise a capital markets operator to offer a product in the manner set out in paragraph 1.2 of these Directives.
- 1.3.3 Further, a licence issued by the Commission under the Securities Act does not allow capital markets operators to receive funds other than as a prepayment for the buying of securities (for example, shares or bonds) when a licensed dealer is acting as a broker or for the acquisition of units in a collective investment scheme or for use in other activities or products regulated by the Commission under the Securities Act.
- 1.3.4 The authorisation and regulation of the receipt of funds that do not conform to products under the Securities Act is the preserve of the Bank of Zambia or the Pensions and Insurance Authority.

#### 1.4 Compliance

In a bid to protect the interests of the investing public, the Commission hereby directs capital markets operators who are, or have, engaged in the prohibited product activity referred to in paragraphs 1.2 and 1.3 to comply with the following:

- 1.4.1 Desist from promoting, marketing or selling products that are not registered or authorised by the Commission;
- 1.4.2 The operators concerned must immediately report prior dealings in the prohibited product activity and submit, within the stipulated timeframe, the information that shall be specified by the Commission in writing to the operator. In addition, the operators concerned must cease such activity forthwith; and
- 1.4.3 Compliance with the Securities Act, No. 41 of 2016: Capital markets operators are to ensure compliance with the Securities Act in their product activity and with the conditions of their licences.

#### 1.5 RESERVATION OF ENFORCEMENT RIGHTS

The Commission reserves its rights under the Act to take enforcement action against capital markets operators to whom these Directives apply. Such enforcement action may be in addition to any action taken against a capital markets operator for the contravention of these Directives pursuant to sections 11 (3) and (4) and 211 (2) of the Securities Act as read with section 218.
