The Value Added Tax (General) (Amendment) (No. 2) Rules, 2019

IN EXERCISE of powers contained in Section *ten, eleven, twelve, thirteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three* of the Value Added Tax Act, the following Rules are hereby made:

Title. Gazette Notice No. 633 of 2018

1. (1) These Rules may be cited as the Value Added Tax (General) (Amendment) (No. 2) Rules, 2019 and shall be read as one with the Value Added Tax (General) Rules, 2018 in these Rules referred to as the principal Rules.
