The Value Added Tax (General) (Amendment) Rules 2019

IN EXERCISE of the powers contained in sections *ten, eleven, twelve, thirteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three* of the Value Added Tax Act, the following Rules are hereby made:

Title, Gazette Notice No. 633 of 2018

1. These Rules may be cited as the Value Added Tax (General) (Amendment) Rules, 2019 and shall be read as one with the Value Added Tax (General) Rules, 2018 in these Rules referred to as the principal Rules.

Amendment of Third Schedule

2. The Third Schedule to the principal Rules is amended by the addition of the item listed in the Table set out in the Appendix to these Rules.
