Regulations 2021

IN EXERCISE of the powers contained in section 89 of the Customs and Excise Act, the following Regulations are made:

1. (1) These Regulations may be cited as the Customs and Excise (Suspension) (Maize) Regulations, 2021.

(2) These Regulations are deemed to have come into operation on 1st January, 2021 and shall stand revoked on 10th February, 2021.

2. (1) The export duty on maize of heading 1005.90.00 exported by the farms specified in the Schedule is suspended to zero percent.

(2) The suspension of the export duty applies where the specified farms export the quantities specified in the Schedule.
