The Road Development Agency (RDA), wishes to state its intention to reserve a strip of land approximately 1.6km at Chalwe, off the M3 Road (Mansa to Mwense) in Luapula Province to a width of ninety-one metres on either side of the centre-line against all use of it.

The aforementioned strip of land has been identified for the purpose of construction of the proposed Kasomeno Mwenda Toll Road One Stop Border Post (OSBP) access road. The proposed access road will provide access to the proposed OSBP and the proposed bridge across the Luapula river, linking Zambia to The Democratic Republic of Congo (DRC). It is for this reason that the RDA wishes to formally notify the general public of its intention to reserve a strip of land approximately 1.6km at Chalwe, off the M3 Road (Mansa to Mwense) in Luapula Province to a width of ninety-one metres on either side of the centre-line against all use of it.

Having satisfied the requirements stated in the Public Roads Act No. 12 of 2002 Clause 43 (4) and pursuant to Clause 27 which reads in part "The Agency may, with the approval of the Minister, by Gazette notice and advertisement in one newspaper published or commonly circulating in the district concerned, declare that any road or part of the road designated or classified as an inter-territorial main road or a territorial main road, district road, branch road or a rural road shall, as from the date to be stated in the notice, cease to be so designated or shall be reclassified or shall be diverted.", the RDA notifies the general public of the official gazetting of the strip of land approximately 1.6km at Chalwe, off the M3 Road (Mansa to Mwense) in Luapula Province to a width of ninety-one metres on either side of the centre-line against all use of it.
