African Swine Fever Outbreak In Southern Province

In accordance with Sections 12, 13, 22, and 23 of the Animal Health Act No. 27 of 2010 of the Laws of Zambia, it is hereby notified for the information of the public in general and the farming community and livestock purveyors in particular that African Swine Fever (ASF), a disease of domestic and wild pigs, has broken out in Southern Province.

In view of this outbreak, the under listed measures will be in force in Southern Province with immediate effect until further notice:

1. Movement of all pigs and pig products within and out of the affected areas have been banned as follows:

- (a) No live pigs, pig carcasses, pig or pork products will be allowed out of Southern Province
- (b) No live pigs, pig carcasses, pig or pork products will be allowed to move from one area to another within Southern Province
- (c) Pig carcasses, pig or pork products from outside Southern Province will only be allowed into Southern Province under strict supervision of the Department of Veterinary Services and if they originate from entities or processing facilities registered by the Director of Veterinary Services.
- (d) Live pigs, pig carcasses, pig or pork products will only be allowed to transit through Southern Province under strict conditions stipulated by the Department of Veterinary Services

2. All pig sale yards, slaughter facilities and processing plants in Southern Province have been closed with immediate effect until the disease is under control

3. Veterinary officers in the affected areas will take any other such measures as deemed necessary for the control of the disease

Any animal found contravening the foregoing measures will be destroyed without compensation and the persons in charge of such animals will be prosecuted.

Any other person or persons found contravening the measures directly or indirectly will also be prosecuted.
