Animal Health Act (Act No. 27 of 2010) and Control of Dogs Act

Rabies Outbreak in Mufumbwe District of North-Western Province

IN ACCORDANCE with Sections 12, 13, 22, and 23 of the Animal Health Act No. 27 of 2010 and provisions of the Control of Dogs Act, it is hereby notified for the information of the general public that Rabies a fatal disease of animals (mainly canines) and humans has broken out in domestic dogs in Mufumbwe Central Veterinary Camp in Mufumbwe district of North-western Province and consequently, the area is hereby declared a rabies infected area.

In view of the outbreak, the under listed control measures shall be in force in the affected area until further notice, but subject to review after 90 days of coming into force of this gazette notice:

1. All dogs in the infected area shall be subjected to mandatory vaccinations against rabies.
2. All dogs in the infected area are hereby restricted to movement within owners' premises and no movements are allowed out of owners' premises.
3. Transportation of dogs in or out of the infected area is banned with immediate effect.
4. Any dog found unsecured or straying in the infected area shall be put down without any notice.
5. Veterinary Officers shall take any other such measures as deemed necessary for the control of the disease.

Any person found contravening the measures outlined in the notice shall be prosecuted and appropriate penalties shall apply.

"Dog owner(s)" includes owner or any person in charge of a dog.

IN ACCORDANCE with Sections 12, 13, 22, and 23 of the Animal Health Act No. 27 of 2010 and provisions of the Control of Dogs Act, it is hereby notified for the information of the general public that Rabies a fatal disease of animals (mainly canines) and humans has broken out in domestic dogs in Sikongo A and Sikongo B Veterinary Camps in Sikongo district of Western Province and consequently the listed areas are hereby declared rabies infected areas.
