The Value Added Tax (General) (Amendment) (No. 2) Rules, 2023

IN EXERCISE of powers contained in sections *ten, eleven, twelve, thirteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three* of the Value Added Tax Act, the following Rules are hereby made:

Title Gazette Notice No. 310 of 2020

1. (1) These Rules may be cited as the Value Added Tax (General) (Amendment)(No. 2) Rules, 2023 and shall be read as one with the Value Added Tax (General) Rules, 2020 in these Rules referred to as the principal Rules.
- (2) These Rules shall cease to have effect on 31st December, 2023.
- Amendment of Third Schedule*
- (3) The Third Schedule to the principal Rules is amended by the addition of the item listed in the Table set out in Appendix I to these Rules.
