**TREATY FOR THE ESTABLISHMENT OF THE
PREFERENTIAL TRADE AREA FOR EASTERN
AND SOUTHERN AFRICAN STATES (P.T.A.)**

Publication of P.T.A. Treaty

IT is hereby notified that the Minister of Trade and Commerce has authorized the publication of the Treaty for the Establishment of the Preferential Trade Area for Eastern and Southern African States (P.T.A.) for general information.

An important feature of the P.T.A. Treaty, which is the Common List of Commodities to be traded within the Preferential Trade Area, is not yet finalized. It is expected that the common list will be completed by March, 1983.

At present the treaty has been signed by 13 States, and nine States have ratified it. The P.T.A. Treaty has now come into force definitively, in terms of Article 50 (1) of the treaty.

However, the provisions of the P.T.A. which concern customs and excise duties and procedures shall only become operative in Zimbabwe when a notice to this effect is published in the *Gazette*, in terms of subsection (2) of section 87 of the Customs and Excise Act [Chapter 177]. This may coincide with the publication and implementation of the P.T.A. common list referred to above.
