ROAD MOTOR TRANSPORTATION ACT [CHAPTER 262]

Renewal of Road Service Permits

HOLDERS of road service permits which are due to expire on the 31st January, 1984, are reminded that applications for renewal thereof must be lodged, on form R.M.T. 8, with the Controller of Road Motor Transportation, P.O. Box 8332, Causeway, not later than the 1st January, 1984.

Subsection (2) of section 9 of the Road Motor Transportation Act [Chapter 262] provides that the Controller shall not consider any application for the renewal of a road service permit unless it is lodged with him at least 30 days before its date of expiry

All holders of road service permits which expire in January, 1984, are hereby notified that, in terms of section 8 of the Road Motor Transportation Act [Chapter 262], the holders of such permits are required, when submitting applications for the renewal of their permits, to substantiate the rate of utilization of each permit during the entire period of validity ending in January, 1984. School-opening, 1984: Temporary Authorities for the Operation of Motor-omnibuses
