Applications in Connexion with Road Service Permits

INTERIM REPORT

The overall financial environment in the first six months of the current financial year was considerably more favourable than had been anticipated at the commencement of the final quarter of 1984. The 1983/84 drought—the third in succession—while adversely affecting the agricultural sector, did not prove to have had nearly as severe a restraint over output as expected and deliveries of major crops to the marketing authorities were significantly greater than in the 1983/84 intake year. Maize sales, nearly half of them by communal farmers, totalled 936 000 tonnes in 1984/85, over 50% higher than in the previous intake year considerably reducing the need for imports. Seed cotton deliveries, at 250 000 tonnes, were also nearly 50% higher than in 1983/84 and with an over 20% increase, to a record 120 000 tonnes, in the volume of tobacco marketed, earnings from agricultural exports were higher.

The Bank's results for the first half of the financial year reflect these better than expected national economic developments. Group unaudited net operating income after provision for taxation and after transfers to internal reserves amounted to \$3 196 000, which represents an increase of 38% over the same period last year and 24% over the record profits of March 1983. Earnings per share rose by 37% to 24,42 cents. Creditable as the Bank's performance has undoubtedly been, however, it needs to be set in the context of continuing high rates of inflation. The annual rate of increase in the average of the upper and lower income urban family consumer price indices was in excess of 16%.

These excellent results are attributable partly to the substantially increased demand for trade finance, particularly in the light of the record tobacco crop which will give rise to potential exports of approximately \$350 million. The much better results also reflect the fact that the cost of institutional borrowing declined due to increased liquidity and lower money market interest rates.

While it would probably be unwise to count upon the perpetuation of such favourable conditions for the second six months, there are nevertheless good grounds for anticipating that by the end of the current financial year the Bank will have continued to show highly commendable results.

DIVIDEND ANNOUNCEMENT

In view of the increased earnings, the directors are pleased to announce the declaration of an interim dividend in respect of the six months ended 31st March 1985 of 11 cents (1984—8.5 cents) per share payable to shareholders registered in the books of the company at the close of business on Wednesday, 8th May 1985.

Persons drafting any kind of notices are strongly advised to follow the guidance offered in—

- (a) the Instructions Relating to the Drafting and Typing of
- Legislation (Attorney-General's Circular 1 of 1978); and the Manual of Style for the Drafting and Preparation of Copy, published by the Department of Printing and Stationery;

which two booklets are intended for complemental use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the Gazette itself and for subsidiary legislation issued as supplements to the Gazette.

- 1. (1) Other than by prior arrangement, only original typing is accepted.
- (2) Carbon-copies are not normally acceptable, other than in cases where the original typing has to be legally retained elsewhere, as, for example, in the case of a proclama-
- (3) Computer print-outs are not accepted automatically, as discussion may be necessary with regard to the extra time and costs involved.
