Sther horses in the race will be paid half the prize after the draw and any of the above prizes or the remaining half, depending on their placing at the race.

The draw for horses will be done in order of favouritism as supplied by the Mashonaland Turf Club on the date of the draw. The most favourite horse will be drawn last. The rules and regulations applicable to the Jockey Club will be strictly applied. In the event of a dead-heat for either the first, second or third place, the prize applicable will be combined and divided equally between the ticketholders. In the event that the race is postponed, the prizemoney will be paid out on the result of the race that was postponed. In the event of the race being abandoned for any reason, the prizes applicable to horses will be drawn for as a lottery in a manner to be decided by the Minister. Only the numbers of the tickets which have drawn a horse will be included in the draw.

- (ii) The remainder of the prize-money will be distributed in smaller ordinary, introducers', introducers' jackpot and consolation prizes. - (iii) Two introducers' jackpot prizes: prize, \$50; introducer, \$500.

Only tickets issued against one written order for 14 tickets in one unit are eligible to win these prizes, provided such written order has been compiled at one and the same time.
