Applications in Connexion with Road Service Permits

 - passengers shall not be allowed access to the deck of a motor-vessel or ferry when it is under way, except—
 - (i) on a ferry where the motor-vehicle is loaded on open deck; or
 - (ii) under special circumstances where the motor-vehicle has to be accompanied by a member of the crew;
 - (iii) where special arrangements have been made prior to the journey for invalids who are unable to walk;
 - Conspicuous "No Smoking" notices shall be exhibited together with notices warning against engines being started before doors leading to rooms are opened and members of the crew shall be stationed to instruct passengers accordingly;
 - a fire patrol shall be maintained on the deck of a motor-
 - vessel or ferry during the voyage; any spillage of petrol shall be cleaned up without delay; buckets of sand, drip trays and mopping up equipment shall be provided for use on the deck of every motorvessel or ferry;
 - the crew of a motor-vessel or ferry which transports motor-vehicles shall be well trained in fire-drill;
 - (g) the number of air changes may be increased when a motor-vehicle is being loaded into or unloaded from a motor-vessel or ferry to ensure that any concentration of inflammable vapours or noxious fumes does not become a health or fire hazard.
