**LABOUR RELATIONS ACT, 1985**

Determination of Labour Relations Tribunal: Dispute Between Associated Mineworkers of Zimbabwe and Chamber of Mines

IT is hereby notified, in terms of subsection (3) of section 117 of the Labour Relations Act, 1985, that the Labour Relations Tribunal has made the following determination in

the dispute between the Associated Mineworkers of Zimbabwe and the Chamber of Mines:—

1. It should not be compulsory for an employer in the mining industry to provide housing for all his employees.
2. Where housing of permanent construction is provided by a mining employer to his employees, he is entitled to charge a rent therefor, calculated in accordance with the "Abrahams formula". The basic factor to be used in the application of the Abrahams formula shall be twenty-five cents per square metre.
3. Where a house is provided by a mining employer, in which services of water, power and refuse removal are provided for the exclusive use of the occupants of that house, the employer should be entitled to charge for such services separately from, and in addition to, the rental of that house.
4. The charges for such services are to be—
  - (a) water: three dollars and seventy-five cents per month, or actual cost where metered;
  - (b) electricity for power points and lighting: seven dollars and fifty cents per month, or actual cost where metered;
  - (c) electricity for lighting only: three dollars and seventy-five cents per month, or actual cost where metered;
  - (d) refuse removal: fifty cents per month.
5. Where electrical power points are not provided in an employee's accommodation, the employer should provide that employee with solid fuel in units of half a cubic metre (stacked volume) of firewood, of fifty kilograms of coal, plus sufficient firewood for kindling.
6. The employer may charge for the provision of such solid fuel at the rate of one dollar and fifty cents per unit of solid fuel.

One Hundred and Eighty-five State Lottery

NOTICE is hereby given, for general information, that the one hundred and eighty-fifth State Lottery will be drawn in public, under the direction of the Minister of Finance, Economic Planning and Development, on December, the 23rd, 1988, at 12.30 p.m. in the State Lottery Hall, Harare. The First Prize will be \$100 000.

Conditions for the draw

1. Tickets with counterfoils will be sold at \$5 each. Based on the face value of all tickets sold, up to 25 per cent. of the total subscriptions may be reserved for social service, public welfare or relief of distress.
2. Prizes

(a) First—as above; Second—\$20 000; Third—\$10 000.  
(b) The remainder of the prize-fund will be distributed in smaller ordinary and consolation prizes.  
(c) There will be no free tickets, no introducers' prizes, no introducers' jackpot prizes and no double and treble prizes.  
(d) If, in the opinion of the Minister of Finance, the prize-fund is insufficient for the purpose, the amounts of the first three prizes listed above will be reduced as directed by that Minister.
3. The draw  
(a) The number of all tickets sold will participate in the draw for all prizes.

- (b) If the Director is satisfied that a fault has occurred in the drawing of a prize-number, a "no draw" shall be announced and the prize shall be drawn again. A ball jamming when coming out of a drum will not, in itself, be considered as a fault. Examples of faults are—  
(i) one or more balls appearing before control-button is pressed;  
(ii) control-button pressed before all balls are in the drums.
- (c) Subject to the provisions of the State Lotteries Act [Chapter 317], when a prize-number has been passed and recorded, no subsequent claim that a "no draw" should have been announced will be considered.
- (d) Only one prize can be won by one ticket-number (section 2) above. If a ticket is drawn, the prize is payable to the party whose name appears on the counterfoil. 4. Payment of prizes  
(a) All cash prizes are free from taxation by the Government, and are payable, in full, by cheque.

- (c) If a syndicate wins a prize, it must nominate one or two members to whom the cheque is to be made payable on behalf of the syndicate.
5. While every effort will continue to be made to publish *Extras* on the required dates, copy *must* be submitted timeously so that it can be programmed into the printing work-flow as soon as it is available.

## GOVERNMENT GAZETTE

### Conditions for Acceptance of Copy

FAILURE to comply with any of the following conditions will result in the rejection of copy, and no responsibility can be accepted if such rejection should affect any date contained in such copy or any requirement of publication on a specific date.

Persons drafting any kind of notices are strongly advised to follow the guidance offered in—

- (a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and
- (b) the Manual of Style for the Drafting and Preparation of copy, published by the Department of Printing and Stationery;

which two booklets are intended for complementary use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the *Gazette* itself and for subsidiary legislation issued as supplements to the *Gazette*.

1. (1) Other than by prior arrangement, only original typing is accepted.

(2) Carbon-copies are not normally acceptable, other than in cases where the original typing has to be legally retained, elsewhere, as, for example, in the case of a proclamation.

(3) Computer print-outs are not accepted automatically, as discussion may be necessary with regard to the extra time and costs involved.

2. (1) All copy must be clear and legible, and there must be double or one and a half spacing between the lines.

(2) Any corrections or alterations made by the originator must be clearly effected in blue or black ink, using editorial marks—not proof-reader's marks:

Provided that any copy containing extensive alterations will be rejected.

3. (1) Copy must appear on one side only of each sheet of paper.

(2) Except as is provided in subsection (2) of section 8, paper must not exceed 210 millimetres in width.

(3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance, 7, 7a, 7b, 8, *et cetera*.

4. Photographic copy or copy produced on a duplicating-machine may be accepted if it is abundantly clear.

5. (1) Should any copy—

- (a) exceed 10 pages of double-spaced typing on size A4 paper; or
- (b) contain tabular or other matter which involves complicated setting;

it will be classed as "lengthy" copy, and will be required to be submitted not less than 21 days before the date of closing for the *Gazette* in which it is to be published.

(2) Lengthy copy may be accepted at less than 21 days' notice if—

- (a) the work involved is of a straight forward and non-tabular nature; and
- (b) the total volume of work in hand for the time being permits its acceptance.

6. Notwithstanding anything to the contrary contained in these conditions, any copy—

- (a) which is of national importance, and which is originated as a matter of urgent necessity, may, by prior arrangement, be accepted late for the current week;
- (b) may, due to shortage of staff or to technical consideration, be delayed until conditions permit its processing.

7. Copy must not be submitted as part of a letter or a requisition. It must appear on a separate sheet of paper, on which there is no instruction or other extraneous matter.

8. (1) In cases where notices have to be published in tabular form, copy must be drafted *exactly* as it is to appear. If printed forms for any such notices are unavailable, advertisers must prepare their own forms. While it is not necessary to include the preamble, the box-headings must be there, and, where applicable, the number of the form; for example, "Insolvency Regulations—Form 3".

(2) In the case of copy for tabular notices, the provision of subsection (2) of section 3 does not apply.

9. Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out—

- (a) the name and address of the advertiser; and
- (b) the debtor's code-number, if any; and
- (c) the required date or dates of publication.

10. (1) If a typographical error occurs in the *Gazette*, it is rectified as soon as possible by a correcting notice without charge to the ministry or department concerned, subject to the following conditions—

- (a) that such error is reported to the editor within three months from the date of publication; and
- (b) that the relevant copy, upon re-examination, is proved to be abundantly clear; and
- (c) that the correction of such error is legally necessary;

(2) If a drafting error is not detected before publication, the originating ministry or department is required to draft its own correcting notice, take it to the Attorney-General for vetting, and pay for such notice to be published.

(3) For the removal of doubt—

- (a) a typographical error is made by a typographer;
- (b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.
