## POLICE ACT [CHAPTER 98]

## Promotion of Officers

IT is hereby notified, in terms of subsection (2) of section 14 of the Police Act [Chapter 98], that His Excellency the President has, in terms of paragraph (a) of subsection (1) of section 94 of the Constitution of Zimbabwe, promoted, in the Zimbabwe Republic Police:—
