 - Introducers: \$1 000; \$500; \$250.
 - (ii) The remainder of the prize-money will be distributed in smaller ordinary, introducers, introducers' jackpot and consolation prizes. If, in the opinion of the Minister, the prize-fund is insufficient for the purpose, the amounts of the first three prizes listed above will be reduced as directed by that Minister.
 - (iii) Two introducers' jackpot prizes of \$1 000 each Oily tickets issued against one written order of 12 tickets or more in one unit are eligible to win these prizes, provided such written order has been compiled at one and the same time. Prizes not won will be carried forward and used to increase the jackpot prizes in the following unit. These prizes will be diawn after the draw for ordinary prizes has been completed.
