, NATIONAL MUSEUMS AND MONUMENTS ACT [CHAPTER 313]

Declaration of a National Monument: Domboshawa Rock Art
Site Area

IN terms of section 21 of National Museums and Monuments Act [Chapter 313], the Minister of Home Affairs, on the recommendation of the Trustees of the National Museums and Monuments, hereby declares the monument described hereunder to be a National Monument.

Description of monument

The Domboshawa Rock Art Site is located within the following bundary—

- (a) beginning at the access road to Domboshawa at UR-056-528;
- (b) following the northern edge of the grove of trees ("Rambakurimwa") along a contour ridge from UR-056-528 to a contour ridge along the foot of Domboshawa Hill at UR-058-528;
- (c) following the contour ridge around the foot of Domboshawa Hill from UR-058-528 to a track at UR-064-532;
- (d) following this track around the foot of the hill from UR-064-532 to UR-068-532;
- (e) following the foot of the hill from UR-068-532 to the track at UR-071-529;
- (f) following the track around the foot of the hill from UR-071-529 to UR-071-525;
- (g) following a straight line from the foot of the hill at UR-071-525 to the foot of the hill at UR-067-522;
- (h) following the foot of the granite slope around the hill from UR-067-522 to a stream at UR-057-517; and incorporating a grove of trees at the south eastern foot of the hill;
- following the eastern bank of the stream from UR-057-517 to the foot of the hill at UR-058-521;
- following the foot of the granite slope from UR-058-521 to the existing boundary between the foot of the hill and housing stands near UR-056-522;
- (k) following this existing boundary between the foot of the hill and housing stands;
- following the boundary along the eastern edge of existing fields (tilled by Mrs. Mapondera) from the foot of the hill at UR-056-524 to the starting point of UR-056-528.

LAND ACQUISITION ACT, 1992

Preliminary Notice to Compulsorily Acquire Land

NOTICE is hereby given, in terms of subsection (1) of section 5 of the Land Acquisition Act, 1992, that the President intends to acquire compulsorily the land described hereunder for resettlement purposes.

Any owner or occupier or any other person who has an interest or right in the said land and who wishes to contest to the proposed compulsory acquisition may lodge his objection, in writing, with the Minister of Lands and Water Resources, Private Bag 7767, Causeway, Harare, on or before the 30th of June, 1996.

Any owner or occupier or any other person who has an interest in the said land and who wishes to claim compensation in terms of Part V of the said Act for loss or deprivation of the rights resulting from the acquisition of the land may submit his claim, in writing, in terms of section 22 of the said Act, to the Minister of Lands and Water Resources, specifying in detail—

(a) the nature of his loss or deprivation of rights; and

(b) the amount of the compensation claimed by him and the basis on which it has been calculated including any actual expense or loss suffered directly as a result of the acquisition.

Copy for all notices to be set in tabular form must be received by 11 a.m. on the Friday preceding the Friday of publication.

Any copy which is received after the respective closing-times will automatically be held over for insertion in the *Gazette* of the following week, in which case no responsibility can be accepted if the purport of the notice is thereby nullified.

When public holidays occur, the normal closing-times are varied, and such variations are notified in the *Gazette* in advance.
