The notification must set out the candidate's qualifications and the subjects the candidate wishes to take. If the candidate has already sat for some of the subjects prior to the 2004 sittings, there is no need for a fresh application, but the candidate must give an indication of subjects previously sat for, those ones he/she was exempted from, if any, and those ones he/she wishes to sit for in 2005. If applying for the first time, the candidate must bring with him/ter the written notification required by this notice, the original degree/diploma certificate held by him/her, an original transcript of the same, and eight copies of the degree/diploma and transcript.

Notice is further given that all candidates will be required, in terms of subrule (b) of (1) of rule 9, to remit together with their written notifications the appropriate fee, as set out in the Schedule.
