#### CONSTITUTION OF ZIMBABWE

Notice of Acquisition of Agricultural Land under section 16(B)(2)(a)(iii) of the Constitution

NOTICE is given, in terms of section 16(B)(2)(a)(iii) of the Constitution of Zimbabwe, that the Minister responsible for Lands hereby acquires for and on behalf of the State, the Land identified and described in the Schedule for the purposes of settlement for agriculture, land organisation, forestry, environmental conservation, the utilisation of wild life or other natural resources and relocation of persons dispossessed in consequence of utilization of land for either of the foregoing purposes.

Further take notice that of the ownership of acquired land with full title therein is vested in the State is with effect from the date of publication of this notice in the Gazette.
