- Subject to section 25(5), the shares in any subsequent share by the Savings Bank may be allotted to the State and additionally or alternatively to persons other than the State in such circumstances and subject to such terms and conditions as the Board may determine with the approval of the Minister.
- Subject to section 25(5), the Savings Bank shares may be transferred by the holders subject to such terms and conditions as may be prescribed or as may be determined by the Minister in consultation with the board:

Provided that no fresh restrictions shall be imposed in the transferability of any share while it is held by a person other

At all times at least fifty-one per centum of the Savings Bank's issued share capital shall be held by the State or by nominees on behalf of the State.
