LAND ACQUISITION ACT [CHAPTER 20:10]

Preliminary Notice to Compulsorily Acquire land

NOTICE is hereby given, in terms of section 5(1) of the Land Acquisition Act [*Chapter 20:10*], that the President intends to acquire compulsorily the land described in the Schedule for urban development.

A plan of the land is available for inspection at the following offices of the Ministry of Lands and Rural Resettlement between 8 a.m. and 4 p.m. from Monday to Friday other than on a public holiday on or before the 16th August, 2010.

Any owner or occupier or any person who has an interest and right in the said land, and who---
