- (4) The consequence of this approval is that the receipts and accruals of Macroeconomic and Financial Management Institute of Eastern and Southern Africa and the salaries and emoluments of the expatriate employees and internationally recruited Zimbabwean professionals of Macroeconomic and Financial Management Institute of Eastern and Southern Africa [MEFMI] are exempted from income tax.
