PETROLEUM ACT [CHAPTER 13:22]

Basic Specification for Imported Fuel

IT is hereby notified that the Petroleum Regulatory Authority Board has, in terms of section 4(1)(c) of the Petroleum Act [Chapter 13:22], set the specification for diesel that can be used in Zimbabwe at no more than 500ppm of sulphur and for petrol at a maximum of 0.008g/1 of lead.

It is further specified that the sale of petrol in Zimbabwe shall meet the standard of minimum RON rating of 93. No oxygenates shall be permitted.

It is further notified that all fuel, either imported or blended, shall be subject to tests to determine whether it is within the required specifications.

Every importer of fuel shall be required to produce a certificate of quality as specified by these provisions:

Provided that the prohibition shall not apply to fuel required for industrial use, which exceeds the specifications and for which a written authority has been granted by the Authority.

The effective date of specifications will be the date of publication of this notice.
