# IN THE HIGH COURT OF ZIMBABWE Held at Harare.

In the matter between Bigboy Ellard, plaintiff, and Josephine Ellard (née Mpala), defendant.

TO: Josephine Ellard (née Mpala) whose current whereabouts is unknown to plaintiff.

WHEREAS Bigboy Ellard the plaintiff did, on 16th January, 2006, apply to the High Court of Zimbabwe, Harare, for leave to sue you, Josephine Ellard (née Mpala), the defendant, by publication.
