ENVIRONMENTAL MANAGEMENT ACT [CHAPTER 20:27]

Intention to make Declaration of the Protection of Harare Wetlands

NOTICE is hereby given, in terms of section 136 of the Environmental Management Act [Chapter 20:27], as read with section 113(1) of the same Act, that it is the intention of the Minister to declare the land described in the Schedule as wetlands (hereinafter in this notice referred to as "Harare Scheduled Wetlands").

The coordinates in the Schedule are given to the nearest three metres. The coordinates and locations described in the Schedule are indicated on the Wetland Map of Harare (scale 1:30 000), available for inspection by members of the public at the offices of the Environmental Management Agency during normal working hours: (Harare Office, Block 1, Makombe Complex, corner Herbert Chitepo Avenue and Harare Street).

Any person who wishes to make any representations relating to the proposed declaration is invited to lodge such representations in writing to the Environmental Management Agency and address to—
