#### NATIONAL MONUMENTS

Name of monument National Heroes Acre

#### Description of monument

National Heroes Acre is a burial ground and national monument in Harare. The 49 495 hectares site is situated on a ridge 7 kilometres from Harare along the main Harare-Bulawayo road. The shrine is a national monument of Zimbabwe to commemorate those who fell in the struggle for national liberation and the contemporary and future sons and daughters of Zimbabwe whose dedication and commitment to the nation justify their burial at this sacred spot.

This area is 49,495 hectares. Then in a south-easterly direction for a distance of 58,31m to point R grid reference (TR 8665 2758) then in a north-easterly direction for a distance of 533,10m to point S grid reference (TR 8686 2807). Then in a north-westerly direction for a distance of 156,52m to point T grid reference (TR 86722814) then in a north-westerly direction for a distance of 107,70m back to the starting point A on map sheet 1730 D4 of the 1:50 000 map series and on map sheet TR8427 of the 1:5 000 map series.

Sikombela Restriction Camp Sikombela Nationalist Detention Camp is located on Farm 45 Chemagora Purchase Area in the District of Gokwe. Starting at point A this being grid reference (44564689) proceed in a south-easterly direction for a distance of 89,50m to point B grid reference (4464 4687) then in a south-easterly direction for a distance of 90,44m to point C grid reference (4467 4679). Then southerly for a distance of 110,00m to point D grid reference (4467 4668) then in a south-westerly direction for a distance of 76,42m to point E grid reference (4462 4663). 
