Notice of Nomination to fill the Vacancy among Party-list Members of the National Assembly

PETROLEUM ACT [CHAPTER 13:22] (No. 11 of 2006)

Exception from Levels of Mandatory Blending of Anhydrous Ethanol with Unleaded Petrol

IT is hereby notified that, in terms of section 4(1) of the Petroleum (Mandatory Blending of Anhydrous Ethanol with Unleaded Petrol) Regulations, 2013, published in Statutory Instrument 17 of 2013, as amended by Statutory Instrument 81 of 2014, the Minister approves the current level of mandatory blending to 15 per centum.

The blending of ethanol and unleaded petrol at E15 is now sustainable because there is now adequate supply of ethanol, to sustain blending at the 15 per centum level.

The consequence of this approval is that all licensed operators shall, from the date of publication of this notice, be mandated to sell unleaded petrol which is blended at 15 per centum.
