SCHEDULE

1. CHIEF MUTUMBA

Starting from the eastern boundary of Teregwai where Nyamaruro river crosses the district boundary follow Nyamaruro river north eastwards so as to include Chihuri clinic up to the confluence of Nyamaruro river and Mupfure river, then follow Mupfure river Northwards so as to include Ganza village up to Kaziro dip tank follow a straight line up to Kaziro Hill peak so as to include the dip tank. From Kaziro Hill peak turn southwards then curving eastwards so as to include Katsime village up to Zvitokwe stream. Continue moving eastwards so as to include Muchenje Hill up to Bindura to Mt Darwin road. Follow the main road southwards up to Madziwa Hall follow a straight line so as to include Madziwa Rural Hospital and Madziwa Police station up to Gwetera River near Dikira Dam. Turn southwest following a straight line up to Haramba hills, continue moving southeast following Chinzvinzvi River up to Marimira Hill. From Marimira Hill move south eastwards so as to include Kajevhu village up to Eben Dam. From Eben Dam follow Mupfurudzi River westwards up to its boundary with Maringe village turn south eastwards so as to include Madzivanzira and Hore villages up to Chimburukwa hills.

2. CHIEF MADZIWA

Starting from the eastern boundary of Teregwai estate follows Nyamaruro River north eastwards so as to include Nyamaka village and Chihuri clinic to the confluence of Nyamaruro River and Mupfume River. Follow Mupfure River northwards so as to exclude Kaziro dip tank, up to Mabhonzo bridge, from Mabhonzo bridge turn north east towards to the climax of Kaziro hill so as to include Gorejena village. From the peak of Kaziro hill turn southwards curving towards the eastern direction so as to include Manyika village. Then follow a straight line to the northern foot of Hambadye Hill up to the main road that is Bindura-Mt-Darwin road. From the main road follow straight line eastwards so as to include Zvisokwe dam up to Goora-Madziwa Mine road. From this road proceed south

westwards so as to exclude Hwaramba and Manyara village passing through three tributaries so as to include Chawasarira Village up to Kakovakemuganhu. Follow Kakovakemuganhu westwards so as to include Tongogara 2 village to Kamp Haven Dam so as to exclude Boarder Gezi Village. Then follow Gwetera River northwards so as to separate Nyamaropa area and Madziwa area to the confluence of an unknown stream.

3. CHIEF BUSHU

Starting from the confluence of Mupfurudzi, River and Mazowe River. Follow Mazowe River southwards then southwest to the confluence of Mazowe and Nyaguwe. Follow Nyaguwe southwards to the confluence of Nyaguwe and Umwindsi River. From the confluence of Umwindsi and Nyaguwe follow Umwindsi south westwards to the south eastern corner of Mumugwi farm and follow the southern boundary of Mumugwi farm which connects to the southern boundary of Bython farm up to south to western corner of Bython farm. Then follow the western boundaries of the following; Bythorn, the Poort, Woodlands estates up to the north western corner of woodlands estate so as to include them. Then follow the northern boundaries eastwards to the western boundaries of Ceres A then northwards to the southern corner of Woodlands B. Then follow the southern boundary of Woodlands B westwards to the western comer of Woodlands B. Then follow the western boundary northwards, then eastwards as to include it. From the north eastern corner of Woodlands B follow the western boundary of Burnleigh to Pote River. Follow Pote river south westwards then southernwards, then eastwards to the eastern boundary of the Avilion Farm of Bindura so as to exclude it, then northwards to the eastern corner of the farm, then follow the northern boundary of the bend farm eastwards to the south western corner of Usaramo Farm. Follow the western boundary corner of the following farms Usaramo and Sunray so as to include them. From the northwestern of Usaramo Farm follow Mazowe River eastwards to the southern corner of Caldon A farm. Then follow the western boundary of Caldon A farm as to include it to the south eastern corner of Umurudzi ranch, then along the western boundary so as to include it to the south corner of Cloud end farm. Follow the southern boundaries of Cloud End Farm and Roxlyn Farm. Then follow the western boundary of Roxlyn Farm to the south western comer of the Derries so as to include them. Then follow the southern boundary of the Derries Farm. Follow the western boundary of Derries Farm to the Mupfurudzi River. Follow Mupfuridzi River eastwards to Eben Dam as to include Dam as to include it from Eben Dam wall. Follow Mupfuridzi River eastwards so as to include the following farm lot 8,7,6,4, 3,2,1 up to the confluence of Mupfurudzi River and Zvirungurira River. Then follow Mupfurudzi River eastwards, northwards then eastwards, then to its confluence with Mazowe the starting point.
