4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.

5. (1) Should any copy—

- (a) exceed 10 pages of double-spaced typing on size A4 paper; or

IT is hereby notified that the Minister of Public Service, Labour and Social Welfare has, in terms of section 80(1) of the Labour Act [Chapter 28:01], published the Collective Bargaining Agreement set out in the Schedule which was registered in terms of section 79 of the Act.

SCHEDULE

1. Statutory Instrument 150 of 2010, is hereby amended by the repeal of the whole section 1 and substituted with the following—

Salaries and wages

- (a) The minimum salary or wage applicable to all employees increase by 48% from ZWL\$12 410,00 to ZWL\$18 367,00, for Grade A1 employees.
- (b) —
 - (i) housing allowance for employees in urban zones increases from USD\$45,00, per month to USD\$60,00, per month, payable at the prevailing auction rate;
 - (ii) housing allowance for employees in areas with ginneries increases from USD\$22,50, per month to USD\$30,00, per month, payable at the prevailing auction rate.
- (c) —
 - (i) transport allowance for employees in Harare remains at USD\$30,00, per month, payable at the prevailing auction rate;
 - (ii) transport allowance for all other employees in urban areas as per graded zones remains at USD\$15,00, per month payable at the prevailing auction rate.
- (d) Ginning shift allowance remains at USD\$10,00, per shift, per month, payable at the prevailing auction rate.
- (e) Notwithstanding the date of signing, the effective date for the above increments shall be 1st June, 2021.
- (f) The agreement is binding on all companies within the Cotton Industry.
