Customs and Excise (Suspension) (Amendment) Regulations, 2021 (No. 254).

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 235 as read with section 120 of the Customs and Excise Act [Chapter 23:02], made the following regulations:—

- 1. These regulations may be cited as the Customs and Excise (Suspension) (Amendment) Regulations, 2021 (No. 254).
- 2. The Customs and Excise (Suspension) Regulations, 2003, published in Statutory Instrument 257 of 2003, are amended by the repeal of section 9(AA) and the substitution of the following—

"9(AA) Suspension of duty on fertilised poultry eggs for hatching imported by approved poultry breeders

Duty is wholly suspended on fertilised poultry eggs for hatching of tariff code 0407.11.00 imported by approved poultry breeders, with effect from 1st October, 2021, to 31st March, 2022 (for a period of six months), in the quantities listed in the schedules below—
