1. This notice may be cited as the Statute Law Compilation and Revision (Omission of Constitution of Zimbabwe Amendment (No. 20) Act, 2013) Notice, 2022.

2. The Law Reviser has revised and updated the Constitution of Zimbabwe, formerly appearing as the Schedule to the Constitution of Zimbabwe Amendment (No. 20) Act, 2013 by omitting, in terms of section 16(1) of the Act, the Constitution of Zimbabwe Amendment (No. 20) Act, 2013.

3. It is further notified that the next edition of the Constitution will be titled "Constitution of Zimbabwe".

EXPLANATORY NOTE

(This does not form part of the notice, but merely explains its contents)

The object of this notice is to omit the amending and repealing statute of the Constitution of Zimbabwe, 1980, which omission the Law Reviser is capable of doing under the Statute Law Compilation and Revision Act [*Chapter 1:03*].

Postal and Telecommunications (Licensing, Registration and Certification) (Amendment) Regulations, 2022 (No. 1)

IT is hereby notified that the Minister of Information, Communication and Technology, Postal and Courier Services has, in terms of section 99 of the Postal and Telecommunications Act [*Chapter 12:05*], made the following regulations: —

1. These regulations may be cited as the Postal and Telecommunications (Licensing, Registration and Certification) (Amendment) Regulations, 2022 (No. 1).

2. Section 2 of the Postal and Telecommunications (Licensing, Registration and Certification) Regulations, 2021, published in Statutory Instrument 12 of 2021 (hereinafter referred to as the ("principal regulations"), is amended—

- (a) in the definition of "paging system" by the deletion of "send" and substitution of "sends";
- (b) in the definition of "trunked system" by the deletion of "if" and substitution of "of".

3. Section 5 of the principal regulations is repealed and the following is substituted—

"5. (1) The Telecommunications Licence for Network Facilities Services shall authorise a licensee to build, own, and manage telecommunication network facilities for purposes of leasing or reselling capacity to telecommunications operators.

(2) The network facilities include-

- (a) dark optical fibre cables;
- (b) copper cables;
- (c) towers and associated site equipment;
- (d) ducting and associated civil works.".

4. Section 9(2) of the principal regulations is repealed and the following is substituted—

"(2) Unless specified in the licence document, a telecommunication licence for special circumstances shall be a

short-term licence issued under special circumstances such as testing, research, emergency and or disaster relief.".

5. Section 10(2) of the principal regulations is repealed and substituted with the following -

"(2) Applications for a telecommunications licence for special services: rural fixed broadband wireless access systems shall be made in writing to the Authority and applicants shall, in connection therewith, supply such information as the Authority may require.".

6. Section 12 of the principal regulations is repealed and the following is substituted—

"12. (1) The Telecommunications Licence for internet access provision authorises the licensee to construct, develop and maintain a public telecommunications network for connectivity and internet services.

(2) An application may be made for any one of the following subcategories of the licence—

- (a) class A which authorises the licensee to offer internet protocol telephony; or
- (b) class B which authorises the licensee to offer public data, internet connectivity and internet services but limiting the licensee from offering internet protocol telephony:

Provided that, the licensee shall provide essential and emergency services such as emergency telecommunications services, operator assistance, customer assistance, crime stoppers, child helpline, health helpline, fire services, ambulance, anti-corruption, human safety and life, among others, free of charge.".

7. Section 15(6)(a) of the principal regulations is amended by the deletion of "the connection or interconnection of the telecommunication" and substitution of "the connection or interconnection of the telecommunication".

8. Section 24(3) of the principal regulations is amended by the deletion of "applicationinn" and substitution of "application in".

9. Section 28(3) of the principal regulations is amended by the deletion of "pplciation" and substitution of "application".

10. Section 29(1)(d) of the principal regulations is amended by the deletion of "ameauture" and substitution of "amateur".

11. Section 30(4) of the principal regulations is amended by the deletion of "Secod" and substitution of "Second".

12. Section 31(4) of the principal regulations is amended by the deletion of "vesse" and substitution of "vessel".

IT is hereby notified that the Minister of Local Government and Public Works, in terms of section 83 of the Rural District Councils Act [*Chapter 29:13*], read with section 224 of the Urban Councils Act [*Chapter 29:15*], hereby makes the following notice:—

Title

1. This notice may be cited as the Chegutu Rural District Council-Chegutu Municipality (Declaration of Joint Committee) (Risboro Urban Development) Notice, 2022.

Establishment of committee

2. (1) The Chegutu Rural District Council and Chegutu Municipality Joint Committee is hereby established.

(2) The committee shall be a body corporate, capable of suing and being sued in its own corporate name.

(3) The agreement set out in the Schedule shall regulate the joint committee.

SCHEDULE

PREAMBLE

Whereas by virtue of Resolution Number SFC01/03/21 Dated 02/06/21 and Number OFC86/9 dated 31/05/21, respectively, made by Chegutu Rural District Council and Chegutu Municipality, the parties have resolved to participate in the joint management of Risboro Farm, it is now agreed as follows:

Areas of joint interest

 The area to be jointly managed is Risboro Farm situated in the district of Chegutu in between the area administered by Chegutu Municipality and that administered by Chegutu Rural District Council.

Interpretation

2. In this notice-

"the agreement" means this agreement;

Chegutu Rural District Council-Chegutu Municipality (Declaration of Joint Committee) (Risboro Urban Development) Notice, 2022

- "business day" means any day other than Saturday or Sunday or public holiday in Zimbabwe;
- "Joint Committee" means the committee made up of the members as appointed from time to time in terms of section 224 of the Urban Councils Act [*Chapter 29:15*] and section 83 of the Rural District Councils Act [*Chapter 29:13*].

Objectives of committee

The objective is for the development of the remainder of Risboro Farm commonly known as Risboro Farm into an up market urban settlement.

Appointment of committee members

4. Each party will appoint or second three (3) members from its Councillors or members to the joint committee as provided for in the Urban Councils Act [*Chapter 29:15*] and Rural District Councils Act [*Chapter 29:13*]:

Provided that the rural district council may appoint additional institutional members in terms of section 83 of the Rural District Councils Act [*Chapter 29:13*].

Tenure of office of committee

5. (1) The Committee shall hold office during their office tenure periods as provided for in section 226 of the Urban Councils Act [*Chapter 29:15*], and section 85 of the Rural District Councils Act [*Chapter 29:13*].

(2) The Committee shall elect their Chairperson at the first meeting who shall hold office for twelve (12) months—and the office of the Chairperson shall be alternated between the two (2) parties. The Chairperson shall have a casting vote should there be a tie amongst the joint committee in addition to the deliberative vote.

Functions and powers of committee

6. (1) The Committee shall have similar competences as provided in the Second Schedule and Third Schedule of the Urban Councils Act [*Chapter 29:15*], and any other that Councils can lawfully execute.

(2) There shall be a technical committee made up of officials from the two Councils and institutions to advise the joint committee.

Expenses

7. The parties shall share the expenses equally between themselves and in terms of section 224(4) of the Urban Councils Act [*Chapter 29:15*] and section 83(3) of the Rural District Councils Act [*Chapter 29:13*].

S.I. 83 of 2022

Costs

8. The parties shall jointly bear the costs incurred and incidental to the negotiation, preparation, execution and implementation of this agreement.

General

9.(1) This Agreement constitutes the sole record of the agreement amongst the parties in regard to the subject matter thereof and supersedes all prior agreements amongst the parties or any of them in regard to the subject matter thereof.

(2) If any provision of this Agreement is held or found to be invalid or unenforceable or contrary provisions of any law, such provision shall be deemed to have been severed from this Agreement and to *pro non scripto*:

Provided that all of the remaining terms of this A greement shall continue to be of full force and effect and to bind the parties.

(3) The provisions of this Agreement shall be binding upon the successors in title and assigns of the parties. Accordingly, the rights and obligations of each party arising out of or pursuant to this Agreement shall devolve upon and bind its legal personal representatives, successors in title and permitted assigns.
