The Department of Roads in the Ministry of Transport and Infrastructural Development intends to engage Engineering Consultants companies that will design and supervise the construction works of Dema, Esigodini, Skyline, Lion's Den, Mupfurdza and Flamingo Toll Plazas.

The Department of Roads now invites eligible consulting firms ("Consultants") to indicate their interest in providing the services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services.

The short-listing criteria are:

1. A brief description of the firm's organization and an outline of recent experience on assignment of similar nature. For each assignment, the outline should indicate, inter alia, staff deployed, duration of the assignment, contract amount and firm's involvement.
2. Any comments or suggestions on the Terms of Reference, a list of the services and facilities to be provided by the Client.
3. A description of the methodology and work plan for performing the assignment.
4. The list of proposed staff team by specialty, the tasks that would be assigned to each staff team member and their timing.
5. Certified Copies of Professional Certificates.
6. Curriculum Vitae of key Personnel.

8. The Prospective Bidders should submit preliminary Designs of Toll Plaza attached in their Expression of Interest (EOI).

If a Consultant considers that it does not have all the expertise for the assignment, it may obtain a full range of expertise by associating with individual Consultant(s) and/or other Consultants or entities in a joint venture or sub-consultants, as appropriate, the documentation should be attached there into the EOI.
