Made and entered in accordance with the Labour Act [Chapter 28:01], as amended from time to time, between the Zimbabwe National Water Authority of the one part (herein referred to as "the employer") and the Zimbabwe Water Trade Union (herein referred to as "the employees" or "the trade union") of the other part, being parties to the National Employment Council for the Undertaking of the Zimbabwe National Water Authority (herein after referred to as "the Council").

- 1. Parties agreed to increase the current basic salary by sixty per cent (60%) for employees in grades 15 to 8 only, resulting in a minimum basic salary of ZW\$117 606,00.
  - 2. The allowances shall be paid as follows:
    - (i) Housing allowance shall remain at 10% of basic salary.
    - (ii) Water and electricity allowance shall remain at 5% of basic salary.
    - (iii) Transport allowance shall be maintained at USD\$22.00 per month to be paid at the prevailing interbank rate.
- 3. The gross minimum salary is ZW\$144,113 .00 effective 1st July, 2022.
