Customs and Excise (General) (Amendment) Regulations, 2022) (No. 112)

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 235 as read with section 120 of the Customs and Excise Act [Chapter 23:02], made the following regulations:—

- 1. These regulations may be cited as the Customs and Excise (General) (Amendment) Regulations, 2022 (No. 112).
- 2. The Customs and Excise (General) Regulations, 2001, published in Statutory Instrument 154 of 2001, is amended in section 144V (Rebate of duty on motor vehicle imported under the health services motor vehicle scheme) by the repeal of the table in subsection (5) and the insertion of the following—
