COMPETITION ACT [CHAPTER 14:28]

Notice of an Investigation into Alleged Restrictive Practices in the Production and Distribution of College Students Attires by College or Tertiary Learning Institutions

It is hereby notified, in terms of section 28 of the Competition Act [Chapter 14:28] that the Competition and Tariff Commission has commenced investigation into investigations into alleged restrictive practices by Seke Teachers College as defined in terms of section 2 of the Act. Section 28 of the Act empowers the Commission to undertake investigations into any restrictive practice which the Commission has reason to believe exists or may come into existence.

Investigations have been prompted by allegations that Seke Teachers College (the College) is requiring students, during enrolment, to procure branded protective clothing and sporting attire exclusively from the College. The College is alleged to be involved in the production and distribution of branded attire to students. It is further alleged that students who procure college attire from alternative suppliers remain indebted to the institution to the same value for uniforms, upon completion of their studies resulting in them failing to collect their diploma certificates.

The Commission's preliminary concerns are that other colleges or tertiary learning institutions may be engaging in similar restrictive practices that affect students. The alleged restrictive practices may result in students being restricted from exercising their right to choose suppliers of college clothing attire. The practice also restricts other producers and distributors from supplying college attire to students, where students are required to exclusively procure from the college. *Prima facie*, the alleged practice may constitute a restrictive practice as defined in terms of section 2 of the Act.

It should be noted that the commencement of the investigation neither pre-supposes that the conduct being investigated is anti-competitive nor that Seke Teachers' College or any other College has violated the provisions of the Act. The Commission will, in accordance with the provisions of section 28 of the Act, conduct investigations in the tertiary education sector focusing on the provision of college clothing attire to determine whether the alleged practices directly or indirectly restrict competition.

In view of the foregoing, the Commission hereby gives notice to all interested stakeholders and the general public to submit their written representations to the Commission stating how they have been affected by the issues under investigation, not later than 14 days from the date of publication of this notice.
