REGULATION

1. Citation and commencement
2. Amendment of Schedule to the Regulations

IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 2) Regulations, 2020, and shall come into operation on 13th June, 2020. Citation and commencement
2. The Regulations are amended by substituting, for the Schedule thereto, the following new Schedule — Amendment of Schedule to the Regulations
